

## CONSENT FOR THE PROCESSING OF PERSONAL DATA AND IMAGES

The processing also includes the **receipt, assessment and storage of personal data, CVs, photographs, videos or recordings** provided by the participant, as well as possible future contact in case of selection or future professional collaborations.

**LEGAL BASIS:** Processing is based on the **data subject's express consent**.

**DATA DISCLOSURE:** Data may be shared, where necessary, with companies belonging to the **LETSGO Group** (including El Perejil Entertainment, S.L.; Letsgo Theatre & Entertainment Enterprises, S.L.; Kolfer Enterprises, S.L.; Letsgo Enterprise, S.L.; Letsgo Oceans, S.L.; and Letsgo Entertainment, S.L.), as well as with the **co-organiser Balich Wonder Studio S.p.A.**, exclusively for the management of the selection process or evaluation of candidates within the corresponding project.

No international data transfers will be made without the **prior consent** of the data subject.

**DATA RETENTION:** Personal data will be retained for a **maximum of 12 months** from the end of the casting process, unless the participant expressly authorises its retention for future calls.

**DATA SUBJECT RIGHTS:** You may exercise your rights of **access, rectification, erasure, objection, restriction of processing and portability** by writing to [privacidad@letsgocompany.com](mailto:privacidad@letsgocompany.com), indicating "Data Protection – Casting" and attaching a copy of your identification document.

You may also lodge a complaint with the **Spanish Data Protection Agency** ([www.aepd.es](http://www.aepd.es)) if you believe your rights have been infringed.
